2023 Concrete Sidewalk Replacement

DESCRIPTION OF WORK:

Work will consist of concrete sidewalk replacement at various locations throughout the Town of Fort Macleod as identified by Town Staff (as outlined in Appendix A).

Contractor Scope of Work is as follows:

- Supply, place, and broom finish concrete sidewalk at a minimum of 100mm, based on CSA standards. Concrete to be 35 MPa at 28 days, with a maximum slump of 75mm.
- Concrete curb and/or gutter a to match existing, as per City of Lethbridge Dwg. STR 03.
- Removal of any surplus base material as required in order to achieve sufficient concrete depths.
- Supply, place, and compact crushed aggregate as required minimum 25mm to a maximum of 75mm.
- Expansion joints to be installed as required. New sidewalk panels to be doweled into existing sidewalk panels.
- Alleys and driveway approaches to be a minimum 150mm thick with 10M rebar, placed every 45-60cm in both directions and tied every second rebar intersection (as per CSA A23.1 Table 17).
- All intersection corners of the sidewalk to be barrier-free as per City of Lethbridge Dwg. STR 11.0.
- Repair the asphalt adjacent to the sidewalk installation matching adjacent asphalt thickness.
- Provide any surveying if required. The Town will not provide survey, all curb is to tie into adjacent curbing.
- 1-year warranty must be provided on all work.
- Perform all associated form removal and site cleanup.

Town Staff will perform the following work:

- Saw cut and remove old sidewalk and cut the asphalt along to curb and dispose of all material.
- Advise on thickness modification, layout and slope of the sidewalks as required.

EXTRA WORK:

The successful proponent may be requested to provide additional replacement of concrete sidewalks with curb and gutter. Any additional items will be paid in accordance with the unit rates provided within this request for quotes.

Submitted quotes must include the following:

- Complete BID FORM with costs for the identified work (location maps in Appendix A).
- List of Staff responsible for the Work.
- Confirmation that resources are available to complete the quoted work by the **completion date of September 30**, **2023**

Notes:

The Town will provide the exact locations of the work once the successful proponent has been selected. The successful proponent must obtain a Town of Fort Macleod Business License. The successful proponent will be expected to satisfy all insurance requirements and per WCB.


